Internet's long memory subject of thoughful drama

The American Theater Group hits another home run with "Right to Be Forgotten," a timely play by Sharyn Rothstein, which tells the story of a young man's misstep early in life, how the Internet magnifies it - and his quest to have it erased so he could live a normal life.

Rothstein's fast-moving snappy dialogue, along with Kathy Gail MacGowan's clever direction and the outstanding cast are a perfect recipe for an interesting, complex and thought-provoking experience exploring the dangers of social media. The right to be forgotten is an actual term-of-art which refers to the right to have private information about a person be removed from Internet searches under certain circumstances.

The play opens with Seth Clayton as Derril Lark, a comparative literature PhD student, having a first meetup over coffee with a young woman, Sarita Imari, played by Leela Bassuk. This shy pair immediately convey the feeling of a young couple's first awkward meeting - and yet we feel the bond these two are creating as they both realize they are each a bit on the quirky side.

We are drawn in by Bassuk's delivery of Imari's train-of-thought about every single thing she is thinking and feeling which is funny and so real. We can also relate to the quiet, poetry-reciting Lark who is clearly beginning to be smitten with Imari.

All is going well and then as they discuss possibly getting together again -Lark reveals he has not given Imari his real name. At this moment the atmosphere completely changes and she is frightened and wants to know why.

He reveals that he once followed a girl around in high school, to the point that it rose to the level of stalking. He realized it was wrong and stopped, but not before the Internet was flooded with "Lurking Lark" and similar name calling. He said that now, even though it is 10 years later, if he had given Imari his real name, she would have looked him up online and never would have met with him.

The story unfolds from there as Lark seeks out an attorney, Marta Lee, played by Maria Jung who agrees to represent Lark pro bono to go against the tech companies to try to erase all the negativity about Lark from the Internet. Jung is outstanding as the fast-talking, quick-witted attorney who wants to do good in the world - and yet also make a name for herself.

We also meet the attorney who represents some of the tech companies, Annie Zahirovic played by Amanda Kristin Nichols. Zahirovic, it turns out, is Lee's old friend from law school, and does not want her to proceed with the case, as it is not in the best interests of her tech-world clients. The two former friends are on

opposite ends of the spectrum in terms of one attempting to be altruistic and the other representing corporate greed. Nichols is terrific as the attorney we love to hate, as she uses underhanded means to try to stop the case from moving for-

Zaven Ovian plays Alvaro Santos, the state attorney general who decides whether the case will be brought to court. We soon learn that he is married and having an affair with Zahirovic. Yes, the plot

Chelsie Sutherland gives a moving performance as Eve Selinsky, the girl who was stalked by Lark. Lee advises Lark to contact her to see if she will forgive him and testify in the case. Her emotions range from anger, to sadness to forgiveness and everything in between. Although her life was also made difficult by the events that took place in high school, she also became part of the problem as we learn later in the play. In fact, all but one of the characters in this play are guilty of some form of wrongdoing.

Within the framework of the overall theme of the right to be forgotten, this play also explores friendship, deceit and forgiveness. It shows that nothing is black-and-white and life is always filled with grays - even if it is not immediately apparent. The six actors in this play each deliver a stellar performance and although the subject matter is serious, there are many funny, tender and lighthearted moments.

The sets are bare, mostly consisting of tables and chairs, which keeps the attention focused on the action of the play, including the social media and newspaper headlines which are projected onto the backdrop of the set at various times.

"The Right to be Forgotten" opened at the Jewish Community Center in West Orange last weekend and will be performed Thursday, Friday and Saturday at 7:30 pm and Sunday at 2:30 pm at The Sieminski Theater on the campus of the Fellowship Village at 8000 Fellowship Road in Basking Ridge.
